DATABASES AND INDEXES

Nurses may access these databases via library websites or directly from the vendor; also, contact a local health sciences library or closest Regional Medical Library (call 800/388-7657). For access to the US National Library of Medicine databases, check the NLM website at www.nlm.nih.gov/databases/. Always check with your library before paying for journal articles online as access via a library gateway may provide options for obtaining the full text of indexed content. Since full-text journal collections are marketed to libraries, not nurses, they are not listed here. Nurses may also obtain the full text of articles — both print and online — via professional memberships, personal subscriptions, and some websites.
