MHST/NURS 603 - Assignment #1 Qualitative Research Assignment Value – 25% of the final grade for the course

Due: on or before the end of Week 6

The purpose of Assignment 1 is to assist you in understanding when and why it is appropriate to use qualitative approaches in research, as well as to help you become familiar with some of the different types of qualitative research, and how they are utilized in research.

Based on the class readings, class discussions, material from the resource forum and any other information you have obtained through additional readings, your objective is to write a scholarly paper addressing the following three tasks:

- provide an overview of the nature of qualitative research
- provide an argument outlining when it is appropriate to use qualitative research methods, or alternatively, you might disagree entirely with the use of qualitative methods.
- select two qualitative methods and provide a compare and contrast of the two methods. Qualitative methods include (but are not limited to) grounded theory, phenomenology, discourse analysis, ethnography, and case study. Use peer-reviewed, published qualitative research examples to provide illustration and context to your arguments.

Your paper should demonstrate a scholarly discussion:

- it is imperative that you follow that APA sample manuscript that is provided in the APA manual.
- it is strongly recommended that you integrate a breadth of materials, including course readings and additional readings from AU library databases (i.e., peer-reviewed publications) to support your arguments and related discussion.
- do not use unreliable resources such as Wikipedia or personal/faculty webpages.
- ensure all citations and references are in accordance with APA specifications.

Assignment 1 is to be a **maximum of 7 pages** (minimum 12 point font, 1 inch margins), excluding the title page, abstract, and references. Submit the assignment to your course instructor via the course Dropbox.
